- Mr. Lawrence asked Ms. Asiedu if she would work with Ms. Cardona since they both represent the Bronx. Ms. Asiedu replied she would discuss such with Ms. Cardona. Ms. Asiedu informed Mr. Lawrence, Sr. she is the Public Advocate Appointee and represents the council citywide not just the Bronx. Ms. Groover mentioned the previous council member appointed as a Bronx Rep for a section of the Bronx had resigned from the council. There was to be a North and South Bronx Rep. for the Council.

District 75 Superintendent, Mr. Louissant welcomed the council and attendees to the calendar meeting. He mentioned the following:

- ♦ He introduced/mentioned the new Principal present Anthony Carsela as well as the AP's. (The New Hungerford Building on the Petrides Campus is the school that was being referred to as some Council members and himself attended the groundbreaking ceremony earlier in the day).
- Mr. Louissant announced the Father's Initiative will continue and introduced Mr. Ray Velez, Family Leadership Coordinator, 75 and organizer.
- ♦ The Instructional Leadership framework, which will "make sure students are hitting the marks to ensure instruction is rigorous and achieve IEP goals".
- Social Emotional Learners and managing behavior as well with Mindfulness.
- Mr. Louissant responded the P9 Walkthrough Report submitted by council as well as thanked them for the report. He added how the Chancellor visited the school as and the additions the school will acquire such as the new music room and OT/PT room.
